Description

INVITATION TO BID

- 1. The Sagay Water District, through the 2015 Corporate Budget by the SWD Board intends to apply the sum of Two Million Pesos (Php 2,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for The Supply and Delivery of Magnetic Flow Meters. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Sagay Water District now invites bids for The Supply and Delivery of Magnetic Flow Meters. Delivery of the Goods is required thirty (30) calendar days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted though open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from Sagay Water District BAC Secretariat and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M. (Monday to Friday) except holidays.

5. A complete set of Bidding Documents may be acquired by interested Bidders from November 03, 2015 to November 23, 2015 from the address given below and upon payment of a nonrefundable fee in the amount of 5,000 for the Bidding Documents, pursuant to the latest Guidelines issued by the Government Procurement Policy Board (GPPB).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- 6. The Sagay Water District will hold a Pre-Bid Conference on 11 November 2015, 10:00 A.M. at the Sagay Water District Conference Room, Sagay City, which shall be open only to all interested parties who have purchased the Bidding Documents.
- 7. Bids must be delivered to the address below on or before 23 November 2015, 10:00 A.M. All bids must be accompanied by a bid security that shall be limited to Bid Securing Declaration or at least one (1) in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
