Description

INVITATION TO BID FOR THE Supply and Delivery of One (1) Unit 4x4 Pick-up Type Vehicle

1. The Sagay Water District, through the 2018 Corporate Budget by the SWD Board intends to apply the sum of One Million Four Hundred Thirty Thousand Pesos (₱ 1,430,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for The Supply and Delivery of One (1) Unit 4x4 Pick-up Type Vehicle. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Sagay Water District now invites bids for The Supply and Delivery of One (1) Unit 4x4 Pick-up Type Vehicle. Delivery of the Goods is required Twenty (20) calendar days from receipt of Notice to Proceed. Bidders should have completed, within Three (3) Years from the date of submission and receipt of bids, a single largest completed contract (SLCC) similar to the Project, equivalent to at least 50% of the ABC. The description of an eligible bidder is

contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

In addition, Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Sagay Water District and inspect the Bidding Documents at the address given below during 9:00 am to 4:00 pm Working Days.

5. A complete set of Bidding Documents may be acquired by interested Bidders on July 25, 2018 from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (₱ 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Sagay Water District will hold a Pre-Bid Conference on August 2, 2018; 10:00 A.M at Sagay Water District Conference Room, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before August 14, 2018; 10:00 A.M. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on August 14, 2018; 10:00 A.M. at Sagay Water District Bidding Room. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Sagay Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
