Description

1. The Escalante Water District, through the NG 2012 Salintubig Project intends to apply the sum of Three Hundred Fifty Thousand Seven Hundred Pesos (P 350,700.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of Water Meters. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Escalante Water District, through the Bids and Awards Committee (BAC) of Sagay Water District, now invites bids for Supply and Delivery of Water Meters. Delivery of the Goods is required Fifteen (15) Calendar Days from receipt of Notice to Proceed. Bidders should have completed, within Three (3) Years from the date of submission and receipt of bids, a single largest completed contract (SLCC) similar to the Project, equivalent to at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

(i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Sagay Water District and inspect the Bidding Documents at the address given below during 9:00 am to 4:00 pm Working Days.

5. A complete set of Bidding Documents may be acquired by interested Bidders on October 22, 2019 from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos Only (P 500.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. Bids must be duly received by the BAC Secretariat at the address below on or before October 30, 2019; 10:00 A.M. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on October 30, 2019; 2:00 P.M. at Sagay Water District Conference Room. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The Sagay Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.

Other Information

Cover the requirements of water meters of various metrological classes which can withstand permanent flow rates from 0.5 m³/11 to 20 m³/h, maximum admissible working pressure equal to or greater than 10 bars and a maximum admissible temperature of 30 degrees Centigrade.

The water meter shall be a multi-jet and dry dial, and magnetic drive type meter. Meter accuracy must conform to ISO-4064 Class-B. Meter Body shall be automotive finished, epoxy coated or electro-statically coated, painted in blue color.

The meter body (or casing) shall be brand- new, manufactured from copper alloy containing not less than 75% copper; or a copper alloy containing not less than 57% copper with an anti corrosion treatment.
