Invitation to Bid for the Supply and Delivery of Seven Hundred (700) pcs. Of 4" dia. X 6.0 meters, C100 uPVC pipe.

1. The Sagay Water District, through the 2015 Corporate Budget by the SWD Board intends to apply the sum of One Million Five Hundred Forty Thousand Pesos (P 1,540,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for The Supply and Delivery of Seven Hundred (700) pcs. Of 4" dia.x6.0 meters, C100 uPVC. Pipe. Bids received in excess of the ABC shall be automatically rejected in bid opening.

2. The Sagay Water District Bids and awards Committee now invites bids for The Supply and Delivery of Seven Hundred (700) pcs. Of 4" dia.x6.0 meters, C100 uPVC. Pipe Delivery of the Goods is required (30) Calendar Days. Bidders should have completed, within Three (3) Years from the date of submission and receipt of bids, a single contract similar to the Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

(i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from Sagay Water District BAC Secretariat and inspect the Bidding Documents at the address given below during 9:00Am to 4:00Pm Working days.

A complete set of Bidding Documents may be purchased by interested Bidders on February 6, 2015 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the

amount of Five Thousand Pesos Only (P 5,000.00).

5. The Sagay Water District BAC will hold a Pre-Bid Conference on February 12, 2015; 10:00Am at the Sagay Water District Conference Room, which shall be open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before February 23,2015; 9:30AM All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on February 24, 2015; 10:00Am at the Sagay Water District Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
